## HIGH ROLLER

Members Promotion LTPS  
Terms & Conditions

1. The promotion will run from Monday 7<sup>th</sup> October 2019 until Thursday 12<sup>th</sup> December 2019.
2. To be eligible to enter, individuals must be financial members of Cessnock Leagues Club.
3. To enter Eligible Entrants must, during the Promotional Period (defined below):
  - a. Swipe their membership card through the Members Rewards Kiosk each day. The amount of tickets earned each day through the Members Rewards Kiosk corresponds with a Members Loyalty Program "STAR Rewards" level. STAR Rewards levels are achieved through loyalty points earned from a Members visitation and spend throughout Cessnock Leagues Club, Paxton Bowling Club & Vincent Street Kitchen & Bar. Visitation Promotion tickets are earned using the following breakdown;  
1 STAR Member maximum 1 ticket per day;  
2 & 3 STAR Members maximum 2 tickets per day;  
4 & 5 STAR Members maximum 3 tickets per day.
  - b. 1 x Ticket for every main meal purchased from Entice Bistro and Café
  - c. 1 x Ticket for every \$20 (cumulative) spent at Cessnock League Club Bar  
Members must ensure they are swiping their membership cards with each transaction to earn their tickets and register their spend.
4. Tickets will be automatically generated through the Club's Point-Of-Sale [POS] system throughout the entire duration of the promotion, until 7pm, Thursday, 12<sup>th</sup> December.
5. Members must then place their tickets in the High Roller ticket barrel.
6. The host will randomly draw 2 tickets from the 'High Roller' promotional barrel at 8pm & 8.30pm each Thursday during the promotional period (4 tickets drawn in total, if tickets are present).
7. Members must be present, and present themselves within 4 minutes to play the High Roller game. If a Member is not present another ticket will be drawn in their place.
8. The drawn members will then each roll 2 Dice in front of the promotional host. Then numbers on each dice will be added together to give a total. The Member with the highest total is the winner.
  - a. The Highest Total roll Member will receive a prize of \$200 cash
  - b. The other Member from the draw will receive \$50 cash
9. Each week at the conclusion of the 8.30pm draw the tickets will be emptied from the promotional barrel, with new tickets to be submitted for the following week's draw.

10. Total cash prize pool during the promotion is \$5,000.
11. Members can only swipe their own Membership Card. Members found to be swiping the Membership Cards of other Members will be disqualified from this promotion.
